NOTICE

- 1. The Undersigned is directed to inform all concerned that in terms of G.O No. 378-EH/1U37/2020 dated 27.06.2020 issued by the Principal Secretary, Department of Higher Education, Govt. of West Bengal the Final Semesters / Years Examinations, 2020 for both PG and UG students stand cancelled in view of COVID-19 pandemic. Instead, the concerned students shall be evaluated with 80% weightage to the best aggregated percentage of previous semesters / years and 20% on internal assessment.
- 2. The blank award slips for theory and practical examinations, subject and paper wise, for UG Part III examinees, 2020 shall be available at *nbuexams.net* on **01.07.2020**. The Colleges shall upload internal test marks both in case of theory and practical examinations out of 100 / full marks for the current year. Marks so awarded by the College are to be uploaded for the use of the Office of the Controller of Examinations. The University shall convert the awarded marks received by the Colleges to 20% while tabulating marks and preparing the final results of UG Part III Examinations, 2020. The Colleges are requested to check and verify the marks uploaded at the portal before final submission online. The last date for submission of internal test marks online by the Colleges for UG Part III students is **10.07.2020**. All Colleges are requested to strictly adhere to last date of submission of marks online in view of the mandate of the above referred order to publish the results within **31.07.2020**.
- 3. The back papers are to be evaluated on the basis of best marks obtained by a student in the previous years.
- 4. The Colleges are requested to preserve answer scripts for internal test examinations which may be asked for submission to the University as and when required.
- 5. The students in the terminal semester of Professional Courses like Law, Management and Teacher's Training shall be evaluated giving 80% weightage to the best of the aggregates of the previous semesters and 20% weightage on the basis of assignment based evaluation.
- 6. The portion of the academic session 2019-2020 affected by imposition of lockdown should be treated as "classes attended" by all the students.
- 7. All students of the intermediate semesters / years shall proceed to the next higher semester / year.

- 8. The students proceeding to the next higher semester / year will have to take admission to the next higher semester / year as per existing rules.
- A special grievance cell w.e.f 11.05.2020 has been constituted at the University of North Bengal to deal
 with the grievances of the students related to the Academic & Examinations due to the prevailing
 pandemic situation under an mail box grievance.cell.covid19@nbu.ac.in
- 10. If a student wishes to appear in a formal examination instead of alternate evaluation method as stated above, he / she shall be given an opportunity to apply for the same through a process to be notified by the University. However, the said examination shall be conducted only after the situation gets normalized and the result of the said special examination will be published within one month of the examination held. The final result marks shall be revised as per the student's performance in the special examination, irrespective of whether he / she secured more or less marks than what was awarded to him/her through alternate evaluation method. To this effect, an undertaking will be obtained from the student for allowing him / her to appear in the special examination.
- 11. The next academic session 2020-2021 shall begin as decided by the State Government when COVID-19 pandemic permits so.
