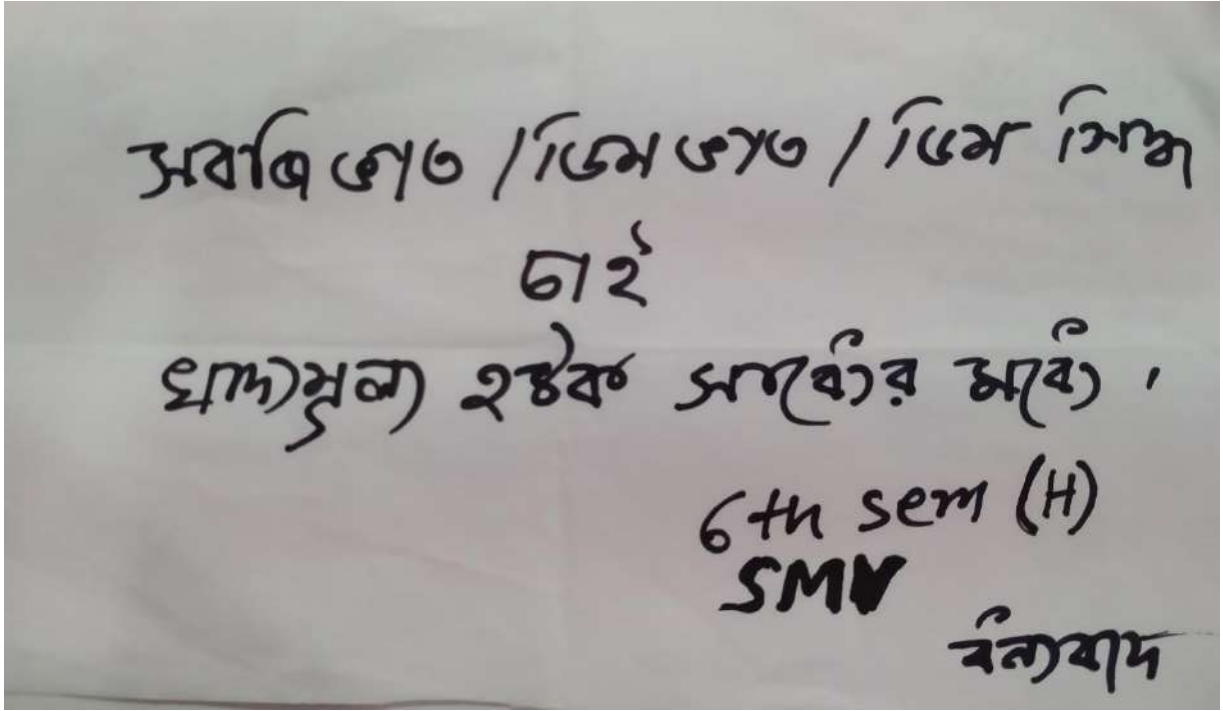


Resolution:
